

AFFILIATE PARTNERSHIP AGREEMENT - RIPPED RHINO COACHING HUB

This Affiliate Partnership Agreement ("Agreement") is made and entered into as of [Date], by and between:

3. RRC Hub's Obligations

RRC Hub agrees to:

4. Compensation & Payment Terms

The Affiliate will earn a commission of **[5] % on each successful referral** that results in a sale/enrolment.

The RRC Hub will earn a commission of **[agreed rate] % on each successful referral** that results in a sale/enrolment.

Payments will be processed on a **monthly basis via PayPal**.

Commission is only applicable for referrals tracked through designated affiliate links.

5. Intellectual Property

The Affiliate is granted a limited, non-exclusive, revocable right to use RRC Hub's trademarks and branding solely for promotional purposes.

The Affiliate shall not alter, modify, or misrepresent any RRC Hub materials.

6. Term & Termination

This Agreement is effective as of the date signed and will continue for [X] months unless terminated by either party with a [X]-day written notice.

RRC Hub reserves the right to terminate the Agreement immediately if the Affiliate engages in unethical, fraudulent, or illegal activities.

7. Confidentiality

Both parties agree to keep confidential any proprietary or sensitive information received during the course of this Agreement.

8. Indemnification & Liability

The Affiliate agrees to indemnify and hold harmless RRC Hub from any claims, damages, or liabilities arising from their promotional activities.

RRC Hub shall not be liable for any indirect, incidental, or consequential damages incurred by the Affiliate.

9. Miscellaneous

This Agreement constitutes the entire understanding between the parties and supersedes any prior agreements.

Modifications to this Agreement must be in writing and signed by both parties.

This Agreement shall be governed by the laws of [Jurisdiction].
